Note:

- * All programs are available depending on whether there is an opening. A \$25.00 fee will be applied for all returned checks.
- * All programs are non-refundable, non-assignable and non-transferable to any other 10 weeks.
- * All classes are 55 minutes of instruction, except for programs #1, #4, #9 and #10 (see above).
- * Tuition is not refundable after the first missed lesson during every 10 week session. For this lesson, a make-up lesson is not guaranteed.
- * The above signed shall not do, print or say anything tending to injure the reputation of the Eminence Dance Studio.
- * All dances created by the Eminence Dance Studio belong to it. You must have the school's permission in order to perform or display them in any way.
- * The membership fee of \$ 25.00 is to be a non-reoccurring single fee payable once per year of uninterrupted sessions. If dance sessions are interrupted, one must renew membership by once again paying the fee.
- * All expenses for participation in performances (costumes, tickets, fees, etc...) are considered additional charges and not included in the tuition.
- * The minimum cleaning charge for use of Eminence Dance costumes will be no less than \$10.
- * Eminence Competitive Team members will be charged a \$15 administrative fee per routine in addition to admission fees charged by the competition.
- * In the 2 month period before any Eminence Dance performance the size of lesson groups may be changed and student's lessons may be moved to different times/groups in order to better organize practice and prepare for the upcoming recital. Should a student miss any such practice, the school has the right to cancel his or her participation in the performance due to unpreparedness.
- * All student participation in performances and other events is up to the discretion of Eminence Dance Studio and its instructors.
- * Eminence Dance may create media of children during its events and utilize said media for promotional purposes.
- * Eminence Dance will not share personal information of students and their guardians but may utilize this information for the purpose of contacting them.
- * One group lesson costs \$25 per student, one couple lesson costs \$45 per student, and one private lesson costs \$90 per student.
- * The discount price for any program for advanced level students is allowed only with one year enrollment in that particular program.
- * All 10 week programs should be paid in full in advance. There is a fee of \$5 if the program is not paid in full prior the start of the following session.
